DECISIONS IN ADMINISTRATIVE PROCEEDINGS

LIBRARY

BIRR, WILSON & CO. CENSURED

An order has been issued censuring the broker-dealer firm of Birr, Wilson & Co., Inc., of San Francisco. The Commission's action was based on findings that, from about February to April 1972, the firm violated antifraud provisions of the securities acts in connection with its offer and sale of common stock of Pacific Northwest Development Corporation. The firm's salesmen were given a "syndicate wire" prepared by the firm which contained material misstatements concerning Pacific's ability to obtain long term financing and generate a profit in its real estate development projects, Pacific's relationships with subcontractors, and prospects for increases in Pacific's net income. The salesmen made material misstatements concerning these matters to certain purchasers and prospective purchasers of Pacific stock.

The Commission's order was issued under an offer of settlement in which the firm, without admitting or denying the charges against it, consented to the above findings and the indicated sanction. In determining to accept the offer of settlement, the Commission considered the firm's representations that it has stopped distributing "syndicate wires", has augmented its compliance program with respect to underwritten issues, and has made changes in the supervisory personnel of its investment banking and syndicate departments. IRA SCHULTZ BARRED

An order has been issued barring Ira Schultz, of Dix Hills, New York, from association with any broker, dealer, registered investment adviser or registered investment company. The sanction was based on findings that, during the period from June 1969 to February 1970, Schultz sold unregistered stock of Imperial Investment Corporation, and recommended the purchase of such speculative and unseasoned stock without having made reasonable inquiry concerning Imperial's financial condition and operations. It was also found that he made false and misleading statements concerning the existence of an independent market for Imperial stock, and his participation in a scheme to manipulate its price.

Schultz consented to the indicated findings and sanction, without admitting or denying the charges against him. (Rel. 34-10812)

ALEXANDER P. GATTI SANCTIONED

An order has been issued revoking the broker-dealer registration of Alexander P. Gatti, of Fresno, California, and barring him from association with any broker-dealer. Gatti may after sixty days apply for permission to become associated with a broker-dealer in a non-supervisory and non-proprietary capacity upon a showing of adequate supervision.

The sanctions imposed were based upon findings that during stated periods between January 1972 and June 1973 Gatti failed to comply with net capital, recordkeeping, customer-information, reporting, hypothecation, credit and confirmation requirements. The Commission's order was based on an offer of settlement in which Gatti, without admitting or denying the charges, consented to the findings and sanctions. (Rel. 34-10816)

COMMISSION ANNOUNCEMENTS

SUSPENSION OF REGULATION A EXEMPTION OF PAMCO CAPITAL CORPORATION MADE PERMANENT

The SEC's order of February 21, 1974, temporarily suspending a Regulation A exemption from the registration requirements under the Securities Act of 1933 with respect to a public offering of common stock of Pamco Capital Corporation (Pamco) of New York has become permanent. Harper Johnson Co., Inc. was the named underwriter for the offering. Under a notification filed on March 28, 1973, Pamco offered 100,000 shares of its common stock at \$.50 per share. According to the order, the Commission has reason to believe that: (a) the offering circular of Pamco contains untrue statements of material facts and omits to state material facts necessary in order to make the statements made not misleading, particularly with respect to the failure to disclose the identity of an undisclosed underwriter, and the failure to accurately state the terms of the offering and the plan of distribution; (b) the terms and conditions of Regulation A have not been met with respect to the failure to accurately identify the directors of the issuer; and (c) the offering was made in violation of the antifraud provisions of the securities laws. COURT ENFORCEMENT ACTIONS

JAMES SHARP ENJOINED

The Atlanta Regional Office announced that on May 22 the Federal Court in Chattanooga, Tennessee, permanently enjoined James Sharp of Wichita Falls, Texas, from violations of the registration and antifraud provisions of the securities laws in the offer and sale of fractional undivided interests in oil and gas wells, promissory notes of Destiny Oil and Gas Corporation and the common stock of Scenic Oil and Gas Corporation, both of Chattanooga. Sharp consented to the entry of the Court's order without admitting or denying the allegations of the Commission's complaint. (LR-6379)

INVESTMENT COMPANY ACT RELEASES

AETNA FUND, INC.

An order has been issued on an application of Aetna Fund, Inc. and Aetna Income Shares, Inc., both mutual funds, and Aetna Financial Services, Inc. The order permits the sale of securities of the mutual funds at prices other than the current public offering prices described in the prospectuses of such mutual funds, which prices include sales charges of such funds, when such securities are purchased with the proceeds of life insurance or annuity contracts issued by Aetna Life and Casualty Company or its affiliates. OPPENHEIMER FUNDS

An order has been issued on an application of Oppenheimer Fund, Inc., Oppenheimer A.I.M. Fund, Inc., Oppenheimer Time Fund, Inc. and Oppenheimer Income Fund, mutual funds, and Oppenheimer Management Corporation, the Funds' principal underwriter, to permit the shareholders of Oppenheimer Monetary Bridge, Inc. (formerly, Oppenheimer Financial Bridge Fund, Inc.), to exchange their shares for shares of the other Funds at net asset value plus a sales charge equal to that of the Fund being acquired, less the sales charge paid on the Bridge Fund shares at the time they were originally purchased.
