MOKAN PRODUCTS, LTD. ENJOINED

The Chicago Regional Office announced that on March 17 Judge Joseph E. Stevens, Western District of Missouri, entered an Order of Permanent Injunction against Mekan Productions, Ltd. The Order was entered by default for Mekan's failure to answer or otherwise appear in the lawsuit. The Order enjoins Mekan from violations of the antifraud provisions of the securities laws. According to the Complaint, Mekan and David G. Riggs, its President, violated the antifraud provisions of the securities laws by overstating Mekan's revenues and its backlog of incomplete projects in an S-18 registration statement. (SEC v. Mekan Productions, Ltd. and David G. Riggs, WDMO, No. 87-1111-CV-W-8, filed December 16, 1987). (LR-11687)

INVESTMENT COMPANY ACT RELEASES

MONTGOMERY ACCEPTANCE CORPORATION

An order has been issued amending a prior order exempting Montgomery Acceptance Corporation, formerly Oxford Acceptance Corporation, from all provisions of the Investment Company Act in connection with the issuance and sale of mortgage-backed securities and equity interests. (Rel. IC-16339 - March 28)

MONTGOMERY ACCEPTANCE CORPORATION IV

An order has been issued exempting Montgomery Acceptance Corporation IV, formerly Oxford Acceptance Corporation IV, from all provisions of the Investment Company Act in connection with the issuance of collateralized mortgage obligations by limited partnerships that Applicant may form and the sale of beneficial ownership interests in such limited partnerships. (Rel. IC-16340 - March 28)

Another order has been issued exempting Applicant from all provisions of the Act in connection with the issuance of collateralized mortgage obligations by one or more trusts and the sale of beneficial ownership interests in such trust or trusts. (Rel. IC-16341 - March 28)

MONTGOMERY ACCEPTANCE CORPORATION III

An order has been issued amending a prior order exempting Montgomery Acceptance Corporation III, formerly Oxford Acceptance Corporation III, from all provisions of the Investment Company Act in connection with the issuance and sale of mortgage-backed securities and equity interests. (Rel. IC-16342 - March 28)

DELISTINGS GRANTED

Orders have been issued granting the application of the New York Stock Exchange to strike the specified securities of the following companies from listing and registration thereon: COMPUTERVISION CORPORATION, common stock, \$.05 par value, and 8% convertible subordinated debentures, due December 1, 2009. (Rel. 34-25518); and PACO PHARMACEUTICAL SERVICES, INC., common stock, \$.01 par value. (Rel. 34-25519)

The Informations, to which both men pleaded guilty, charge them with fraud in connection with the purchase of stock in Coastal Bank of Portland, Maine, prior to a public announcement while in possession of material, non-public information. The Informations further allege that the confidential information was misappropriated from Suffield Bank and provided by Robert DiGennaro, the former president and chief executive officer of Suffield Bank.

Each pleaded guilty to one count of insider trading for which they could face up to five years imprisonment and a \$250,000 fine. (U.S. v. Weisman, CR No. H-88-42 (PCD) D. Conn.); (U.S. v. Russolillo, CR No. H-88-41 (PCD) D. Conn.) (LR-11777)

**GEORGE INSERRA, JOHN GIURA, NICHOLAS GENTILE,
JOHN INSERRA AND DENNIS GIORGI INDICTED**

The New York Regional Office announced that, on May 25, a Grand Jury charged George Inserra and John Giura with conspiracy to commit racketeering acts, including securities fraud. Inserra was also charged with receiving kickbacks in the form of brokerage commissions directed to his credit by investment advisers, including Stein Roe & Farnham, intended to influence their selection as advisers to the Teamster funds.

G. Inserra, Giura, Nicholas Gentile and John Inserra were further charged with conspiracy to violate the antifraud provisions of the Securities Exchange Act of 1934 (charges identical to those alleged in the Commission's administrative proceeding) in that they created a holding account in which securities purchased therein were transferred to the Teamsters if their price declined and to associates of the Inserras if the price rose.

The indictment also alleged that the Inserras, Gentile and Giura conspired to obstruct the Commission's investigation and administrative proceeding.

G. Inserra and Dennis Giorgi were also charged with ERISA violations and income tax fraud. Separate indictments charged Robert Sfeir and Bernard Turi with income tax fraud. (U.S. v. George Inserra, et al., 88 Cr. 104, NDNV 1988) (LR-11779)

(collectively, Partnerships), and Equitable Capital Management Corporation (Adviser) determining that: (1) the Independent General Partners of the Partnership are not "interested persons" within the meaning of Section 2(a)(19) of the Act, of the Partnerships or the Adviser, and (2) limited partners who own less than a 5% ownership interest in the Partnership will not be "affiliated persons" (as defined by Section 2(a)(3)(D) of the Act) of the Partnership or its partners solely by reason of their status as limited partners. MASSMUTUAL EQUITY INVESTORS TRUST

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
