COMMISSION ANNOUNCEMENTS

MOU ISSUED

On August 10, the Commission issued a Memorandum of Understanding, signed May 23rd, 1990, with the Institut Monetaire Luxembourgeois. (International Series Release No. 137)

ADMINISTRATIVE PROCEEDINGS

KIRK A. KNAPP BARRED

The Commission announced that it has ordered Kirk A. Knapp (Knapp) be barred from association with any broker, dealer or investment adviser. Knapp failed to answer an Order which instituted administrative proceedings against him on May 31, 1990. The Commission found, based on the Order Instituting Proceedings, that on January 3, 1990, Knapp was permanently enjoined, after trial, by the U.S. District Court for the Western District of Michigan, Southern Division, from violating the antifraud provisions of the federal securities laws. The Commission also found that in the offer and sale of the initial public offering of Centrac Associates, Inc. (Centrac), Knapp made materially false and misleading statements and omissions regarding, among other things: the use of the proceeds from the offering and the fact that 37% of the shares of the offering were parked in the accounts of nine nominees who Knapp knew would not pay for the shares. The Commission also found that Knapp caused his firm, K.A. Knapp & Co., Inc., to bid for and purchase Centrac stock before the distribution of the Centrac offering was complete. (LR-28316)

INVESTMENT COMPANY ACT RELEASES

THE PENN MUTUAL LIFE INSURANCE COMPANY

A notice has been issued giving interested persons until September 4 to request a hearing on an application filed by The Penn Mutual Life Insurance Company, Penn Mutual Variable Annuity Account III (Separate Account), Penn Mutual Equity Services Inc., and Janney Montgomery Scott Inc., for an order pursuant to Section 6(c) of the Investment Company Act granting exemptions from the provisions of Sections 26(a)(C) and 27(c)(2) of the Act to the extent necessary to permit the deduction of mortality and expense risk charges from the assets of the Separate Account pursuant to certain variable annuity contracts. MATHERS FUND AND MATHERS AND COMPANY

A notice has been issued giving interested persons until September 5 to request a hearing on an application filed by Mathers Fund, Inc. and Mathers and Company, Inc. for an order, pursuant to Section 6(c) of the Investment Company Act, amending an existing order which conditionally exempts the applicants from the provisions of Section 15(f)(1)(A). The requested relief would eliminate certain conditions in the existing order. (Rel. IC-17664, August 9)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved a rule change submitted by the Chicago Board Options Exchange (SR-CBOE-89-30) to make the eligibility requirements for market makers participating in the CBOE's Retail Automatic Execution System (RAES) in SPX/NSX options permanent and to incorporate these eligibility requirements into the Exchange's Rules. Publication of the order is expected to be made in the Federal Register during the week of August 13. (Rel. 34-28322)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change by the Philadelphia Stock Exchange (SP-PHLX-90-17) to amend the PHLX's Schedule of Charges and Fees in order to establish a new Equity Specialist Fee has become effective under Section 19(b)(3)(A) of the Securities Act of 1934. (Rel. 34-28324)
